# ASSOCIATE MEMBERSHIP FAQs

## **BENEFITS**

Associate Members will have the following privileges, in addition to full use of the grounds per Club rules:

- Access to the pool limited to current guest policies, with the exception of having to attend with Full Member. *(For example... An Associate Member that lives in-county would be limited to use of the pool twice per month at a rate of \$4.00 per visit. But, as a member of the organization, Associate Members will not be required to have a Full Member sign them in).*
- Full access to the restrooms and concession stand when the pool is open.
- Ability to rent facilities at member rate.
- Ability to vote at membership meetings

The following information should answer questions you might have about the Associate Membership application process and procedures.

### **To whom do I give my completed application?**

Any board member or lifeguard may accept your application and payment. If paying in cash, please make sure you ask for a receipt. Applications can also be mailed to PO Box 240641, Charlotte, NC 28224-1836

### **How much is an Associate Membership?**

- Single Membership \$100.00
- Couple Membership \$125.00
- Family Membership \$150.00

### **Please note:**

- Additional adults over 18 years old that are not your children **BUT** that reside with you in your home are an extra \$50.00 per person. Proof of residency is required. *(See below for list of acceptable forms of proof).*
- New Memberships also will incur an additional one time \$50.00 application fee.
- Discounts do not apply to the additional adult fee.
- Gate and Tennis Court Key is included in Associate Membership Fee

### **Can I make payments?**

#### **Current Members**

(1) Pay dues in full on or before January 31 and take 10% off... (2) Pay dues in full at the posted rate between February 1 and February 28. (3) Payment Plan: First payment due on or before February 14 to qualify.

- 02/14 – First Payment of at least 25% of total dues
- 03/14 – Second Payment of at least 25% of total dues
- 04/14 – Third Payment of at least 25% of total dues
- 05/14 – Final Payment of the balance of your account. *(Paid in full)*

**New Members** also have payment options depending on the time of year they join.

- Join between January 1 and February 14:
  - Pay in full and have the \$50 processing fee waived
  - Take advantage of the above payment plans

# ASSOCIATE MEMBERSHIP FAQs

- Join after February 15:
  - Pay in full and have the \$50 processing fee waived
  - Pay 50% of total dues, plus \$50 processing fee with application and the remaining 50% of dues is due within 30 days (*No discount*)

## **Are you offering any discounts or specials?**

- Half priced membership for anyone joining after July 15<sup>th</sup>.
- Just for the 2008 season, we are waving the \$50.00 application fee as a promotional incentive.

## **What is the application fee?**

The application fee is \$50.00; it helps to pay for badges and related membership paperwork. It is a one time fee for new members.

## **Who is considered a new member?**

A new member is defined as anyone who has not been a member for a period of one year.

## **What is the additional adult fee?**

An additional adult is anyone who resides in the household who is not a child of the primary member. The additional adult fee is \$50 per person and is paid annually. All additional adults must show proof of residency.

## **What are acceptable forms for Proof of Residency?**

Acceptable forms of identification showing proof of residency include: utility bills, drivers license, insurance policy, social security documentation, social services documentation, INS documents, military orders, veterans administration documents, military orders, or valid passport.
